Probate – Grant Only – Fixed Fee

You are instructing us to administer the Estate of the deceased on your behalf. As part of this we will:

- Identify who can administer the Estate.
- Consolidate the information provided by you on the value of the Estate
- Prepare the appropriate Inheritance Tax Return
- Prepare the Oath
- Submit the application to the Probate Registry to obtain the Grant of Representation

Our agreement does not include:

- Obtain the Will
- Obtain or verify the value of the assets in the estate.
- Identify the Beneficiaries of the Estate
- Prepare the Estate Accounts
- Pay any liabilities of the Estate
- Distribute the assets in accordance with the Will/Rules of Intestacy
- Dealing with Income Tax or Capital Gains Tax Issues (including the filing of Tax Returns)

How much does this service cost?

This is subject to the Probate Registry and their turnaround times.

Probate – Full Administration (not contested) – Hourly Rate

You are instructing us to administer the Estate of the deceased on your behalf. As part of this we will:

- Identify who can administer the Estate
- Obtain the Will
- Gather information on the value of the Estate
- Identify the Beneficiaries of the Estate and carry out a Bankruptcy Search against them.
- Complete the IHT205 form
- Prepare the Oath
- Submit the application to the Probate Registry to obtain the Grant of Probate/Letters of Administration
- Collect in the Assets of the Estate
- Prepare the Estate Accounts.
- Pay any liabilities of the Estate
- Distribute the assets of the Estate in accordance with the Will/Rules of Intestacy

On average a standard estate is dealt with within 6-9 months. Typically, obtaining the grant of probate takes 16-20 weeks. Collecting assets then follows, which can take between 10-12 weeks. Once this has been done, we can distribute the assets, which normally takes 4-6 weeks.
